- 1. Motion Ancel, second Stauffer, that the Agenda be approved as presented. All ayes.
- 2. Motion Akin, second McGinnis, that minutes of the regular meeting held January 11, 2011 be approved as presented. All ayes.
- 3. Motion Akin, second Stauffer, that payroll due in the amount of \$89,272.57, covered by voucher #8423 be approved as presented. Roll Call Vote: Akin-Aye. Ancel-Aye. McGinnis-Aye. Stauffer-Aye. Bertsch-Aye. Motion carried.
 - Motion Ancel, second Stauffer, that bills due in the amount of \$86,129.82, covered by voucher #8424 be approved as presented. Roll Call Vote: Ancel-Aye. McGinnis-Aye. Stauffer-Aye. Akin-Aye. Bertsch-Aye. Motion carried.
- 4. Brief Public Comment: AuSable River Estates representative Duane Pinkelman spoke to the Board about their becoming a Fire Wise community, Michigan's first. The bridge across the AuSable River is inadequate for fire protection and needs to be addressed.
- 5. Bob Schneider, County Commissioner, spoke on behalf of the AuSable River Estates property owners in regard to the St. Helen dam and the AuSable River bridge leading to the privately owned subdivision. The Spicer Group has studied the dam and the bridge. Schneider requests Board approval for RCRC Manager's assistance on getting in contact with bridge engineers and other professional contacts. Board consensus that they have no objection to Manager O'Rourke assisting the group in an unofficial capacity.
- 6. Artesia Youth Park members did not appear for their 7:30 pm appointment, nor has the Land Contract been signed and returned to the RCRC. The matter has been tabled.

- 8. Motion Ancel, second Akin, to extend the current listing on the RCRC office building with Northern Properties for six months. All ayes.
- 9. AmeriCorps volunteer, Sarah Michayluk introduced herself and spoke about her work.
- 10. Motion Stauffer, second Ancel, that Board authorizes Staff to advertise for bids on seasonal supply of materials, (aggregates, blades, concrete, culverts, dust control solutions, emulsion, hot patch/cold patch) and later in the year for construction projects, pavement marking, overband crack fill, asphalt and chipseal as budgeted. All ayes.

- 11. Employee Morale survey results were reviewed and discussed. Communication matters within the RCRC will be addressed with employees. McGinnis suggests that overtime issues be addressed prior to negotiations, with perhaps a consensus being reached.
