- 6. Discussion was held on the borrowing against future road funds. Manager was instructed to continue looking into more information.
- 7. Motion Porath, second Stauffer to accept staff's recommendation and purchase a 2016 Vermeer BC1500 Chipper from low bidder Vermeer of Michigan for a cost of \$39,649. All Ayes. Motion carried.
- 8. Motion Porath, second McGinnis to move forward with the F-97 and F-18 Advance Construction projects. All Ayes. Motion carried.
- 9. Motion McGinnis, Second Porath to allow Clerk Simmons to transfer \$800,000 from the primary road fund to the local road fund for 2015. All Ayes. Motion carried.
- 10. Commissioners handed in their meeting logs for 2016. Clerk Simmons will compile them into a master log.
- 11. Motion Porath, second Stauffer to adopt the Resolution to accept .43 miles of Towerhill Road into the local road system. All Ayes. Motion carried.
- 12. Motion McGinnis, second Porath to allow Chair Akin to sign the 2015 Road Certification books. Roll Call Vote Porath- Aye, Stauffer- Aye, McGinnis- Aye. Akin Aye, Chidester Absent. Resolution declared adopted.
