**a. Description.** The item of work Hydro-Seeding shall consist of Hydro-Seeding meeting the seeding, fertilizing and mulching requirements listed below.

**b. Materials.** The seeding mixture shall be composed of certified seed of the purity, gemination, and proportions by weight, as specified in the following table and be placed at the rate of 250 lbs/acre.

<b>SEED TYPE</b>	<b>PURITY</b>	<b>GERMINATION</b>	<b>MIXTURE</b>
Kentucky Bluegrass	98%	80%	15%
Perennial Ryegrass	96%	85%	20%
Hard Fescue	97%	85%	25%
Dawson Creeping Red Fescue	97%	85%	30%
Tall Fescue	98%	85%	10%

The mulch material shall be an approved Recycled Newsprint or Wood Fiber Hydromulch from the MDOT Qualified Product List and be placed at a minimum rate of 1200 lbs/acre, or as per manufactures recommendation whichever is greater.

The fertilizer shall be MDOT Class A, will consist of equal parts of nitrogen, phosphoric acid, and potash and will be applied at a rate that will provide a minimum of 240 lbs/acre of chemical fertilizer nutrients.

**c. Measurement and Payment.** The complete work as measured for Hydro-Seeding will be paid for at the contract unit price for the following contract item (pay item).

The Roscommon County Road Commission is requesting bids for Aerial Tree Work. The work will consist of cutting trees from the road R.O.W. above the road surfaces. Bidders are required to have an Aerial Bucket Truck and an operator.

\*\*\*Road Commission will supply ground labors and chipper for clean-up.

\*\*\*Minimum 4 hour day and 24 hour notice. We will not pay for travel time.

\*\*\*Limbs will be cut flush to the tree. All limbs will require an aerial bucket truck that can extend up to 30' from ground level.

\*\*\* Contractor must provide all certifications for the aerial truck and operator.

Insurance requirements

The Roscommon County Road Commission requires that a “**Certification of Insurance**” be on file prior to allowing work within the right-of-way of any road under the jurisdiction of the Road Commission.

The certificate of insurance shall contain or include the following:

1. Board of County Road Commissioners and Roscommon County Road Commission and all employees named as addition insured to all coverage.
2. General liability coverage - \$1,000,000 each occurrence.
3. Automotive liability - \$1,000,000 each occurrence.
4. Worker’s compensation – statutory limits.
