- 2. Motion Eckstorm, second Stauffer that minutes from the regular meeting held April 27, 2023 be approved as presented. All ayes. Motion carried.
- 3. Motion Vaughn, second Stauffer that Payroll in the amount of \$84,665.82, covered by voucher #9036, be approved as presented. Roll Call Vote Eckstorm Aye, Stauffer Aye, Vaughn Aye, Wykoff Aye, Porath Aye. Nays None. Motion carried.

- 9. Motion Eckstorm, second Vaughn to purchase 15,000 copies of the map reprint. All Ayes. Motion carried.
